### Membership Qualifications

Medicines Australia consists of firms or companies operating a prescription pharmaceutical business in Australia, either as a separate business or as a division of another business, in any one or more sections of the Industry, which include both research based firms or companies and non-research based firms or companies.

Membership of the Association consists of:

Class 1 Members – research based firms or companies

Class 2 Members – non-research based firms or companies, or affiliates of Class 1 members (where separate participation is desired).

Class 3 Members – firms or companies significantly engaged in research into potential pharmaceutical products, but which have not yet commenced commercial production

Class 4 Members – firms or companies ineligible for other classes of membership which are significantly engaged in the development, testing or registration of prescription pharmaceutical products or which are, in the opinion of the Board of Medicines Australia, engaged with the research-based pharmaceutical industry for a significant part of their business.

### Applications for Membership

All applications for membership must be submitted to Medicines Australia on the prescribed Application Form (a copy of this form is attached and is also available on the website [www.medicinesaustralia.com.au](http://www.medicinesaustralia.com.au)).

The Board may accept or reject any application, and shall not be bound to give any reasons for rejection of any application. The Board also has complete discretion in the determination of the Class of Membership for which an applicant qualifies.

Where the Board accepts an application for membership, Medicines Australia will, as soon as practicable after that determination, notify the applicant of that approval.
